

I am out of the state at this time but if selected at the January meeting I would be able to return by the first meeting in February.




I am a strong advocate for local business (profit and nonprofit) and doing everything we can to help our local citizens

Orion Hughes-Knowles Letter of Interest Open Assembly Position


I, Orion Hughes-Knowles, would like to express my interest in filling the Assembly Seat recently vacated by Phyllis Hackett.
