A Resolution of the City of Angoon, Alaska

A RESOLUTION ESTABLISHING THE CITY OF ANGOON COVID19 TRAVELER MANDATE

WHEREAS, COVID-19 is a respiratory disease that can result in serious illness or death and is caused by the SARS-Cov-2 virus ("virus"), a new strain of the corona virus that has not been previously identified in humans and is easily transmittable person to person; and

WHEREAS, on March 11, 2020, the World Health Organization ("WHO") declared the virus a pandemic; Alaska Governor Dunleavy issued a declaration of public health disaster emergency in response to the anticipated outbreak of COVID-19 in Alaska; and on March 13, 2020, President Donald J. Trump declared a national emergency in response to the virus pandemic; and

WHEREAS, on March 23, 2020, the City of Angoon declared a local emergency in response to COVID-19; and

WHEREAS, according to the Center for Disease Control, the incubation period of COVID19 ranges from 2 to 14 days; and

WHEREAS, this resolution shall have the same authority as an Emergency Order issued by the Mayor pursuant to his authority under AMC 2.66.230.

THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF ANGOON ALASKA:

1. That any traveler coming to Angoon shall self-isolate for no less than two weeks. The only exceptions to this rule are travelers exempted by the Alaska Essential Services and Critical Workforce Infrastructure Order. (attached) All travelers exempted by the abovementioned State Order shall make all efforts to minimize all unnecessary contact with members of the public and shall wear a mask at all time when in Angoon outside of their lodging. This exemption does not apply to any other household member of the traveler.
2. That any person who has tested positive for COVID19 while in Angoon shall self-quarantine until cleared by Public Health Officials as being recovered from the virus.
3. That any person who has been contacted by Public Health Contact Tracing Personnel and notified that they are a close contact of a confirmed case shall self-quarantine until cleared by Public Health Officials as either not infected by the virus or recovered from the virus.
4. That for the purpose of this emergency order, "self-quarantine", shall mean that the person and all members of their household are to remain at their home at all times unless directed otherwise by Public Health Officials or the Angoon EOC.
5. That for the purpose of this emergency order, "self-isolate", shall mean:
 - A. That the person and all members of their household are to practice extreme social distancing in that they are not to make any sort of contact within 12 feet of any community member who is not subject to any self-isolation or self-quarantine requirement.





- B. That the person and all members of their household/lodging shall wear a mask at all times when outside of their home or lodging.
- C. That the person and all members of their household/lodging shall not go to any public place where there is any chance of contact with a non-isolated community member, to include:
1. The Angoon Post Office
 2. The Angoon City Office
 3. The Angoon Community Association
 4. Angoon Trading
 5. Angoon Oil
 6. Angoon Schools
 7. The Angoon Ferry Terminal or Seaplane Base unless the traveler and/or members of their household are leaving or arriving in Angoon.
6. That all people travelling to Angoon shall complete and provide to the City, an Angoon Traveler Declaration Form (attached) before or upon arrival in Angoon.
7. That any violation of this order may be subject to a fine of up to \$500 dollars under an infraction issued pursuant to Angoon City Code Chapter 2.66.080.
8. That this emergency order be effective immediately.
9. That If a positive case is identified in Angoon any time during the effective dates of this resolution, the resolution shall be extended by emergency order for two weeks from the date of the last confirmed positive. If the last positive has been cleared by public health or SEARHC medical as recovered, this mandate shall automatically expire.
